TxALA met in Austin on March 31, 2010, to discuss current activity pertaining to oil and gas issues inclusive of landman licensing that may be entertained on the floor. HAPL lobbyist, Todd Morgan, provided an update and will be our April guest speaker to provide details.

The AAPL President, Rimmer Covington, was present at the meeting and members expressed their desire for improved communication between the AAPL and membership.

The recent AAPL BOD meeting was held in Louisville, Kentucky. Our AAPL regional rep attended but has not provided a report as he indicated it must be approved by the AAPL legal counsel.

Please be advised that I have obtained the following information from attendees; the action to present Bill Rex's motion to form a task force to investigate the ExCom's actions was not voted on as the issue was not given precedence as business item number one as indicated in an email ("My plan at present is to put your request on the agenda as Business Item #1, so that we will have ample time to discuss the issues.") from Rimmer Covington to Bill Rex, dated February 24, 2010. All AAPL director's were copied and all emails forwarded to TxALA members. The President placed as business item number one his motion to approve and ratify ExCom's decisions and actions made on September 11 and 12, 2009, being as follows:

- 1. To physically separate the NAPE Expo LP operations from the AAPL.*
- 2. To secure office space in Irving, Texas for NAPE operations.*
- 3. To retain Robin Forte as the executive manager, EVP and COO of NAPE.*
- 4. To hire a new AAPL EVP.*

The motion was approved and ratified with 32 votes in favor. Although, the NHAPL BOD voted in favor of forming a task force, the motion was tabled due to the President's new agenda. The NHAPL regional rep voted in favor of the motion to approve ExCom's actions and did not abstain from the vote or vote no as other reps did according to their board's vote to form a task force.

APRIL 8TH GUEST SPEAKER

T. Todd Morgan and Morgan Capitol Consulting

Todd Morgan is a native of Abilene, Texas. The son of nurse and a petroleum landman and part-time rancher, Todd left Abilene to attend the University of Texas in 1985. There he received two degrees – a Bachelor of Business Administration in Finance and a Bachelor of Arts in Economics.

Todd began his professional career working for then-Railroad Commissioner John Sharp, following him to the State Comptroller's office in 1991.
